- b. Software


2. E-commerce

3. Priced digital services

- a. Cloud services
- b. Telecommunications services
- c. Internet and data services
- d. All other priced digital services

4. Federal non-defense digital services







Digital economy gross output by activity, 2017-2021









Valuing "free" digital media as a payment to consumers: Impact on real GDP




