DIRECTOR AND CHIEF STATISTICIAN OF THE OECD STATISTICS AND DATA DIRECTORATE

Paul Schreyer was nominated Director and Chief Statistician of the OECD Statistics and Data Directorate in November 2020. He joined the OECD in 1988 and held various positions in the (then) Directorates for Science Technology and Industry, Environment and Statistics.
